# CONSTITUTION OF THE JUNIOR FAIR BOARD

## Article I

Membership: Any boy or girl who resides in Morrow County, attends school in Morrow County, **and** who is enrolled in a youth organization that is based in Morrow County, (4-H, FFA, Boy Scouts, Girl Scouts), or has met the approval of membership through the youth organization that is consistent with their state rules for (i.e. cross-county line membership in 4-H) and is 15 years of age as of January 1 of the current year or a freshman in high school, and has not reached their 19<sup>th</sup> birthday as of January 1<sup>st</sup> of the current year, will be eligible to become a member of the Junior Fair Board. **EXCEPTION: FFA members who are still in high school AND in FFA may show if they are 19 or under, despite not being 4-H age.**

1. Junior Fair Board members must abide by all rules governing Junior Fair.
2. Any member found smoking, drinking, chewing, or anything else illegal for minors will be removed permanently & immediately from the board. If you are in a place where people look up to you (role model) you are not to do any of the above **even if you are of legal age.**

## Article II

The Junior Fair Board will consist of at least 25 members with representatives as follows:

In each case, the chairman of each county group will be responsible for reporting membership selection to the Junior Fair Coordinator by November 15<sup>th</sup>.

## Article III

All members will be selected for a term of 1 year. Each member may return with Junior Fair Board Advisor approval after a year-end evaluation, and Junior Fair eligibility not being exceeded. Those with a negative evaluation may be asked not to return the next year.

## Article IV

The organizational meeting will be held in January of each year. Members interested in serving as an officer **must** turn in an application by December 20<sup>th</sup>. Elections will be held in January of each year. There will be NO nominations from the floor UNLESS no one applies for a position.

## Article V

Junior Fair Advisory Committee: This committee will serve in an advisory capacity to the Junior Fair Board. THE PURPOSE OF THIS COMMITTEE is:

1. To be a liaison between the board and the organization they represent.
2. To provide advice and guidance to the board.
3. To assist in establishing and enforcing rules pertaining to Junior Fair.

Members of the Advisory committee will serve 1-year terms and will be selected by their respective organizations. Committee members should report to the Junior Fair Coordinator no later than November 15<sup>th</sup>.

Membership will consist of a **MINIMUM** of the following:

## Article VI

**ANY member OR advisor who cannot attend a meeting MUST CALL THE JUNIOR FAIR COORDINATOR BEFORE the meeting.**

An excused absence is:

- Death in their family
- Family/personal illness
- School activity in which you participate, county, state, or national award trips
- Or the discretion of the Coordinator

Two unexcused absences from meetings and or mandatory activities/events will lead to an evaluation and potential dismissal from the Board. If a member needs to be replaced, each organization will be responsible for their member. Any member who finds they will not be able to be at the fair must give WRITTEN notice to the board by the June meeting. An additional member will be added to the board to help with summer activities and be an active member on the board. The new member will be eligible based on % of time on the board.

## Article VII

A Junior Fair Board Member MUST exhibit in the Junior Fair the current year of term.

If a Junior Fair Board Member wishes to resign, a letter of resignation must be addressed to:

**Article IX**

Proposed changes to the Constitution and rules governing the Junior Fair must be submitted in writing to the Junior Fair Coordinator no later than October 30<sup>th</sup>.

**Article X**

The Executive Committee will be made up of:

President	Historian
Vice-President	Parliamentary Officer
Secretary	County Extension Educator
Treasurer	Jr. Fair Coordinator(s)
Assistant Secretary/Treasurer	

A MINIMUM of 5, present to do business as an Executive Committee.

Regular meetings require 51% of the whole board in attendance to vote on motions.

**Article XI**

Any Jr. Fair Board member or royalty (male or female) may not be or have been married, be an expectant parent or be a parent.

**Article XII**

Code of Conduct will be followed along with all rules in Junior and Senior Fairbooks.

**Article XIII**

Award and T-Shirt committees of 5 will be standing committees.



# REVISIONS TO THE 2024 MORROW COUNTY JUNIOR FAIR HANDBOOK

## **General Changes:**

- New breeds must be approved by December of the previous year, no new breed classes after January 1st. Exhibitors must enter a breed that is listed in the fairbook, or AOB
- Showmanship must be an animal entered and exhibited in the Jr fair by the same exhibitor. The animal cannot be checked in under another exhibitor.
- Added BBR to #3 Rule now reads "A given exhibit can show in only one class, except for showmanship, BBR, in a group or the horse area. For example, an animal cannot be shown in a Market and Breeding Class.

## **Beef Department:**

- Monday of Fair Weigh In will begin at 4pm.
- Starting in 2025 there will only be 1 entry per division in BBR.

## **Dog Department:**

- The dog show will take place between skillathon and fair.

## **Goat Department:**

- All Market Goats must have their milk teeth intact at fair and born on and after January 1st of the current year.

## **Sheep Department:**

- Lambs are suggested to be born after January 1st and must have their milk teeth at the fair.
- No more than one tack pen per family, items and supplies must be specie specific, all feed must be secured for animal safety, storage units in aisles must not interfere with day-to-day business and number of tack pens will be finalized on Monday evening based on the number of animals brought to the fairgrounds. -Tack pens will follow general rule #14 on cleanliness.
- Natural to be changed to natural colored wool
- Romney has been added under Wool Breeds and Dorper/White Dorper under Meat Breeds
- Wool breeds must have at least 1 inch of wool growth upon arrival on the first Monday of the fair.

## **Rabbit and Poultry Departments:**

- Jr Fair Board Members will check pens in the barn at 10am, 2pm, and 6pm daily during the fair.

## **Livestock Sale**

- Sale Cards will now be submitted online.

# RULES GOVERNING THE JUNIOR FAIR

## Eligibility

Eligibility for Morrow County Jr. Fair participation is possible when the following requirements are met:

1. A child is enrolled in 3<sup>rd</sup> grade **AND** is at least age 8 as of January 1 of the current year. EXCEPTION: Tiger Cubs, Cub Scouts, Brownie Scouts.
2. A child has not reached their 19<sup>th</sup> birthday as of January 1 of the current year (or eligibility ends December 31 of year child turns 19 years old. **EXCEPT FFA members who are still in high school may show if they are 19 or under & in FFA despite not being 4-H age.**
3. Child is a member of one of the following Morrow County youth organizations: 4-H, FFA, BSA Scouts and Girl Scouts.
4. Child is a Morrow County resident or student enrolled in a Morrow County school district or a child has met the approval of membership through the youth organization that is consistent with their state rules (i.e. Cross-county line membership for 4-H)
5. Boys and girls who reside outside of Morrow County but are members of Morrow County Youth groups must direct a letter to the Junior Fair Coordinator, P.O. Box 168, Mt. Gilead, Ohio 43338 giving reason for wishing to participate in the Morrow County Fair. EXCEPTION: 4-H members are to contact the Morrow County 4-H Educator.
6. Any exhibitor in the Junior Fair shall be eligible to exhibit in the Senior Fair by making proper entry as set forth in the Rules and Regulations of the Morrow County Agricultural Society.

## Jr. Fair Passes and Premiums

7. All Junior Fair Exhibitors will pay \$5.00 for a weekly fair pass. The passes will be distributed by the Sr. Fair Board Office. Fair passes should be picked up from advisors.
8. Advisors will also be able to purchase their pass for \$5.00. One Advisor pass for each 5 members of the club/organization will be given. For example, if your club has 15 members and 4 advisors, only three advisor passes will be allowed for that club.
9. All entries, including livestock will be graded A, B, or C with premiums paid as indicated in the fair book.
10. Junior Fair premiums will be paid out in cash, during set hours to be shared in Scarlet & Gray Newsletter & posted in the youth building by Move-in Monday. If premiums are not picked up by the end of fair, they will be forfeited and turned back to Sr. Fair Board. Premiums for livestock projects will be determined by the Skill-a-thon score. For Livestock projects: A - \$5.00, B - \$4.00, C - \$3.00. Still Projects: A - \$4.00, B - \$3.00, C - \$2.00.
11. Any project that is judged before the fair (this includes pre-fair agricultural/miscellaneous judging, FCS projects, Scouts etc.) must be exhibited at the Morrow County Fair to receive a premium.

## Entry Rules and Deadlines

12. Deadline for entries will be on June 7th.
13. Entries may be submitted in FairEntry between May 1st and the 7<sup>th</sup> of June.
13. **CODE of CONDUCT will be enforced.** All exhibitors will agree to terms before submission of entries.
14. Late Entries

- Any entry entered after June 7th of the current year
- Accepted up to the First Monday of Fair (Move in Day)
- To be accepted, the exhibitor must have submitted all needed documents, attended mandatory prefair check-in/weigh-in, uploaded required ID photos, attended Skillathon, and completed Quality Assurance.
- Exhibitors will pay per line to enter: Market projects \$50 per line and Breeding/Still projects \$25 per line.
- Late Fees must be paid to the Jr Fair Coordinator by the end of day on (Move In) Monday of fair

## Animal Entry

15. An exhibitor is limited to 2 entries (1 entry =1 animal) in each class except for **breeding livestock which may show 2/class per breed.**
16. Each exhibitor may show **only 2 market animals in any one division.**  
EXCEPTIONS: **Poultry** exhibitors can take only one pair of each species type and only one turkey.  
**Market Beef** is allowed 3. **Feeder Calves** are allowed 3.
17. New breeds must be approved by December of the previous year, no new breed classes after January 1st. Exhibitors must enter a breed that is listed in the fairbook, or AOB

### **BBR - Bred, Born and Raised in Morrow County**

18. ALL Species- Definition of BBR: Bred-Conceived IN Morrow County, Born-Born in Morrow County, Raised-Raised in Morrow County.

19. Sheep, Swine and Goat BBR market classes will be limited to two entries per exhibitor.

20. Beef are limited to two entries per exhibitor

21. BBR information needs to be uploaded into FairEntry by June 7th. Must include Breeder's full name, address and phone number.

22. The decision as to which animal will be placed in the BBR class will need to be made at the fair weigh in, prior to animal entering scales.

### **23. Livestock Living Arrangement Rules**

Documentation in FairEntry must be made by June 7th if livestock is being kept somewhere other than the exhibitor's home.

Visitations by the Jr Fair Coordinator to homes of exhibitors and their livestock entries may take place in June, July, and August. Said visitations will take place on a lottery basis within each species and the exhibitor will be notified of the impending visit.

### **24. Family Animals**

A family may have a maximum of 2 Family animals that will be checked/weighed in under the family name. Any member of this household would be able to use 1 of these animals. The animal needs to be included on each exhibitor's entries. (Families can share the animal information in FairEntry) If these animals are being used, the Jr Fair Office must be notified. This is for market animals only.

Two family market animals may be weighed in or have ID information uploaded, including pictures, into FairEntry by June 7th.

Example: Each exhibitor may submit photos and information for up to 5 market animals per species. Additionally, they can submit family animal information for up to 2 market animals per species. This exhibitor then has 7 market animals to choose from. An exhibitor may not bring an animal that was only entered on a sibling's entry form. Only those animals entered under their own name may be shown.

### **Move in Day - Monday, August 26th**

25. All Junior Fair *still* exhibits must be in place by 8:00 pm

26. LIVESTOCK MUST be on the grounds by 7:00 pm

27. Weigh Ins will be completed by 7:30 pm

28. Livestock coming from another county fair (Senior Fair) will be permitted to arrive late with prior approval by the Junior Fair Board Executive Committee.

### **Move Out Day - Monday, September 4th**

**29. ALL JUNIOR FAIR BOOTHS IN THE YOUTH BUILDING MUST REMAIN IN PLACE UNTIL 4:00 PM. Dismantling early will result in a \$100.00 fine.**

30. Dairy Cattle are released Sunday of the Fair after 8:00 pm

31. Horses and ponies are dismissed at 3 pm

32. **All other animals will be released by their department at the conclusion of their part of the livestock sale.** Example: All sheep may go home only after the last market lamb has sold. All hogs may go home only after the last market hog has sold. This applies to breeding if there is a breeding show.

33. Clothing projects in the Style Show (and only those items) will be released following the Style Show on Sunday of the fair. - The Junior Fair Board will not be responsible for any item (excluding Jr Fair Booth Items) not removed by the close of the fair at 6 pm, 2<sup>nd</sup> Monday of the Fair (Labor Day) including livestock. **Any item left after 30 days will be disposed of.**

# GENERAL LIVESTOCK RULES

1. Health Regulations for the Senior Fair will apply to the Junior Fair Livestock, found in the Sr. Fair Book.
2. Livestock exhibited in the Junior Fair must be owned by the exhibitor (parent/guardian), cared for and fed by the exhibitor by June 1st, of the current year. EXCEPTION: Steers and market heifers must be owned by December 1, 2023. Please be prepared to show proof of age and possession date if asked.
3. A given exhibit can show in only one class, except for showmanship, BBR, in a group or the horse area. For example an animal cannot be shown in a Market and Breeding Class.
4. All animals weighed/checked in by one exhibitor at the pre-fair date must be shown by the same exhibitor.
5. Any exhibit entered through one youth organization cannot be entered through another youth organization.
6. Judges will place top 5 Market Overall animals, each animal will receive an award, but will not necessarily move up in the sale order.
7. If an animal has been entered in as a breeding animal and a market animal and goes over the scales it will be declared a MARKET animal.
8. Weight discrepancy is settled on the scales. If there is a discrepancy on the scales, the animal will be taken off the scales, scales will be swept off and zeroed out, animal will be put back on the scale and reweighed. 2<sup>nd</sup> weight will be the recorded weight.
9. Underweight and overweight market animals will be shown and graded in special classes and not allowed to compete for Grand Champion. Overweight Feeders and Underweight animals may not sell.
10. Underweight animals may NOT show in BBR classes.
11. There are to be no fresh tattoos or ear notches on registered animals. Tattoos or ear notches are to be totally healed, show no redness or irritation.
12. All MARKET ANIMALS SHOULD BE DRUG FREE WHEN THEY COME ON THE GROUNDS. If not, The Drug Use Notification Form must show the complete information and be properly filled out ONLINE prior to set up Sunday at noon. Failure to comply will be cause for disciplinary action.
13. Entries in Poultry Broiler classes may be any commercial type meat chickens. These birds may be debeaked, dubbed, or subjected to any practice generally accepted in commercial production of meat type poultry.
14. Livestock exhibitors must keep pens clean and animals fed. Water must always be kept in front of all animals, except for cattle which must be watered regularly. If there is a problem, the owner will be notified in person (if possible) and/or by posted notice. They will have 3 hours to correct the problem. If the problem is not corrected within those 3 hours, a second and final notice will be given, allowing 1 final hour to correct the problem. If the problem is still not corrected, the owner will not be allowed to sell the animal and/or will be dismissed from the fair. It will be at the discretion of the Junior Fair Board if they will be allowed to show the following year. Repeat offenders will be dealt with by the Senior Fair Board Department Head.
15. NO BUTT FANS PERMITTED.
16. All exhibitors must be present with their exhibit at the time of judging unless excused by the Executive Committee of the Junior Fair Board. Anyone who shows a project for another exhibitor must be an exhibitor of the Morrow County Junior Fair between the ages of 8(3<sup>rd</sup> grade) and 19. If the above rule is not followed the project will not be judged.
17. Pens, stalls, and cages are to be cleaned by the exhibitor and checked by a Fair Board member before the exhibitor may take final leave of the grounds.
18. NO bedding shall be laid until AFTER 1:00 pm on the Sunday before fair. DO NOT move pens without permission from a Fair Board member. RECOMMENDED BEDDING; sawdust, SMALL chips, or straw. Bark is a hazard to those spreading the manure. If you use large/shredded bark or chips, it is the exhibitors responsibility to remove it by the end of fair (midnight of the last day, unless cleared through a board member).
19. ALL LIVESTOCK ENTERED IN THE JUNIOR FAIR COMPETITION MUST BE HOUSED IN THE SPACE DESIGNATED BY THE MORROW COUNTY JUNIOR FAIR BOARD. Breaking of this rule may be cause for dismissal from the fair.
20. Dead Animal Policy: Animal will be removed immediately from the barn. Family will be contacted and will remove it from the grounds as soon as possible.
21. All Grand Champion Market Beef, Swine, Sheep and Goats must immediately be sent to slaughter following sale.
22. If illness occurs in a barn and animals are quarantined, it will be the owner's responsibility to feed, water, and bed animals until released. Pens are then cleaned on release.
23. Drenching of an animal is prohibited unless diagnosed AND prescribed by a licensed veterinarian, AND a Veterinarian MUST be present when the drenching takes place. All veterinary prescriptions for drenching also need approval of and kept on file at the Jr. Fair Office. - *Drenching of an animal is defined as the act of using an instrument placed in an animal's mouth to orally administer a liquid. Examples of instruments are, but not limited to, drench guns, syringes, bottles, bottles with nipples, straws, hose, pipe, hand, etc.* Animals needing to be bottle fed must also be approved by Jr. Fair Board. (This rule excludes rabbit waterers and nipple waterers for hogs.)
24. Animals MUST be castrated and HEALED by 1<sup>st</sup> Monday of the fair. If NOT, animals will not be able to show or sell.

25. 2:3 Rule is used to help set classes for show. If this rule applies you must have 2 exhibitors and 3 animals to make a class. Each exhibitor is allowed only 2 entries (animals) per class EXCEPT Feeders/Market Beef which may enter 3. ALWAYS choose your breed, we will place you in AOB if need be after entries are submitted. Any underweight animal, in any species, are NOT allowed to show in BBR Classes.

26. Exhibitors should stop in the Jr. Fair Office between 9:30a.m to 4:30pm to write the donor a thank you note. The Jr Fair Board will supply the cards, addresses, and stamps so there is no cost to the exhibitor.

27. Exhibitors are only permitted to sell 1 market animal.

28. Articles exhibited must have been made, grown, or produced since the last fair.

**29. Each exhibitor must turn in a stamped, addressed, (Put the species sold under your return address.) Thank You note for the buyer/buyers to the Jr. Fair Office in order to receive their SALE CHECK. It is recommended that these be turned in to Junior Fair office by the last day of September. ALL CHECKS MUST BE CASHED WITHIN 90 DAYS OF BEING WRITTEN. (SEE Livestock Sale Rules)**

**Practices not reflecting real world agriculture practices and techniques are discouraged. Livestock should be raised and cared for with the spirit and purpose of the project in mind.**

### **Mandatory Livestock Skill-A-Thons, Quality Assurance, And Drug Use Notification Form**

According to Ohio Revised Code, the Morrow County Agricultural Society, and the Morrow County Junior Fair, Exhibitors MUST complete a Drug Use Notification Form (DUNF) and a QUALITY ASSURANCE PROGRAM (QA), see below the breakdown for requirements. Skill-a-thon is required for all animals attending the fair. If the QA program, Skill-a-thon, and the DUNF are not completed according to the guidelines, youth will NOT be allowed to enter or exhibit at the fair.

### **Quality Assurance (QA)/ Horse Safety and Ethics :**

Exhibitors of market and breeding animals must participate in a QA program at least 45 days prior to fair move in day. Morrow County requires that a parent/guardian of a first- and second-year livestock exhibitor attend a QA program, REGARDLESS OF AGE.

Horse exhibitors must participate in a Horse Safety and Ethics program at least 45 days prior to fair move in day.

### **Drug Use Notification Form (DUNF)**

Exhibitors with market steers/heifers, feeder calves, market hogs, market lambs, market goats, market poultry, market rabbits, lactating dairy cows, and lactating goats must complete this online form for each animal by Sunday, 12 noon, prior to fair. Horse exhibitors giving medication during the fair must fill out a DUNF also.

All MARKET ANIMALS SHOULD BE DRUG FREE WHEN THEY COME ON THE GROUNDS. If not, The Drug Use Notification Form must show the complete information and be properly **filled out ONLINE prior to set up Sunday at noon**. All drugs must be listed on the DUNF that have not elapsed the withdrawal time of move in day (1<sup>st</sup> Monday). All market livestock must be drug free on the day of show: the withdrawal time must be complete by the beginning of the show. **FAILURE TO COMPLY WILL BE CAUSE FOR DISCIPLINARY ACTION.**

### **Skill-a-thon and Champion Project Awards**

1. All Junior Fair Exhibitors taking animals are required to participate in a Skill-a-thon for each project they take to the fair. This includes BREEDING & MARKET of hogs, sheep, beef, dairy, poultry, feeders, rabbits, goats, horses, llamas, and dogs. The skill-a-thon grade will determine the project premium dollars.
2. Any Junior Fair exhibitor who does **NOT participate in Skill-a-thon WILL NOT show, sell, or receive their premium for that project.**
3. Age groups will be divided according to showmanship guidelines. Age as of January 1st - Senior (16-19), Intermediate (13- 15), Junior (11-12), Beginner (8-10) Age 8 AND in the THIRD grade.
4. Each species will have at least 4 different skill-a-thon stations as determined by the Jr. Fair Board departments Stations will be posted on the OSU Extension – Morrow County website <http://morrow.osu.edu>
5. ALL exhibitors are required to bring their books/record books. Points will be deducted for not completing or not bringing them to Skill-a-thon.
6. Juniors are recognized for score of 90 pts. or higher and seniors are recognized for score of 95 pts. or higher. The top individual in each age group & species, and an overall winner in each species will be awarded "Champion Project."
7. The "Champion Project" exhibitor for each species will be figured by adding the individual's total skill-a-thon score (100 points possible) and a score from their respective Showmanship classes (1st=100 points, 2nd=96 points, 3rd=92 points, etc.). To be eligible for this award each year, past Senior winners must show in Master Showmanship and will automatically receive 100 pts. Each year. Ties will be broken according to 1. Skill-a-thon station scores, 2. Winning Master Showmanship, 3. Number of participants in showmanship classes/competition. Or 4. Tie breaker questions.
8. Skill-a-thon will take place August 7<sup>th</sup> & 8<sup>th</sup> at the Youth Building on the fairgrounds. Times will be published in the Scarlet & Gray newsletter, extension web site, and letters will be sent to head advisors. If exhibitors cannot participate at Skill-a-thon during scheduled times they should contact the Extension Office **PRIOR** to Skill-a-thon for a makeup test. **These exhibitors ARE NOT eligible for any Skill-a-thon awards. Exhibitors may complete at the Ohio State Fair and this score will count here.**

### **Tampering & Misrepresentation Guidelines Morrow County Junior & Senior Fair**

Tampering and/or misrepresentation as to breeding, age, ownership, custody, and any irregularity in showing or judging will be considered fraud and deception. This applies to all Junior and Senior Fair judging as well as the livestock judging. To maintain a high degree of confidence and integrity in the livestock shows, the Morrow County Agricultural Society reserves the right to disqualify the exhibitor and the exhibitor's assistant who fitted the animal involved.

The following is a listing of guidelines all exhibitors must follow to enter livestock at the Morrow County Fair.

1. All exhibitors must have viable proof of ownership available to prove the entire length of time animals have been owned.
2. Market animals and breeding animals must be owned and under the exhibitor's daily care according to established rules and regulations for the fair. This also includes all small market animals.
3. The official ownership date is the date shown on the bill of sale, unless the animal was bred by the exhibitor, in which calving, or birth records must be shown.
4. Registered breeding livestock must show the exhibitor as the sole owner of the animal on the breed association papers or certificates.
5. All Junior Fair breeding projects must be in the exhibitor's or exhibitor's immediate family name.
6. Any other Junior Fair livestock animal and animal projects must be in possession by June 1st.
7. No exhibitor may show an animal which has previously sold at an auction or sale as a market animal through another fair or livestock show whether or not there is an actual change of ownership. (progressive level of show excluded)
8. Any method used to misrepresent the age of an animal for a class in which it is shown is deceptive and considered illegal.
9. Showing an animal for another individual by claiming ownership in order to show in a specific livestock class is prohibited.
10. False ownership is illegal.

**During the fair, in cases of animals requiring treatment, all medications shall be administered by a licensed veterinarian and the livestock show officials shall be notified. Notify the Jr Fair Office so a new DUNF can be completed online.** The proper form for reporting medications administered to animals can be picked up in the fair secretary's office or Junior Fair office and must be filled out and filed with either the Junior Fair Coordinator for Junior Fair or the Fair Secretary for Senior Fair. **Direct criticism or interference with the judge, show management, other exhibitors, breed representatives or show officials, during or after the competitive event is prohibited. If this happens the Code of Conduct will cover these problems.**

### **901-19-31 Responsibilities of and Assistance Given to Junior Fair Exhibitors**

(A) A junior livestock show exhibitor shall be responsible for the continuous care, grooming and preparation of the livestock entered in the junior livestock show.

(B) An exhibitor may receive assistance in the care, grooming and preparation of the livestock entered in the junior livestock show ***provided that the assistance shall be limited to explanation or minimal demonstration provided by the following:***

In the question of a rule violation, the following due process will be used and recorded:

1. The exhibitor and/or parties involved will be questioned by the Sr. Fair Department Head and by the Junior Fair Department Head and the responsible Junior Fair Board Advisor for that department if Junior Fair is involved.
2. If it is felt a violation has occurred, Fair officials will make recommendations to the designated ethics committee of the Morrow County Agricultural Society. After the committee hears the allegations and/or evidence, they will decide if the case should be brought before the full Board of Directors.
3. In the decision of allegations being brought before the Board, all parties involved will be notified of a meeting date and time with all parties having the right to present their views and/or evidence.
4. Upon hearing the case, the Fair board will make a ruling. All rulings will be made within 24 hours of the allegations.
5. When satisfactory evidence has been obtained by the Fair board that any of the livestock rules or rules governing the other departments of the fair have been violated the exhibitor and/or the exhibitor's family may be barred from showing in future agricultural fairs. The minimum number of years of disbarment is three (3) years before the right to a review. In case any premium shall have been awarded to animals or exhibitors shown in violation of this rule, the Fair board will require the exhibitor to refund all premiums, trophies, awards, ribbons and sale money under each violation. Unless fraud and/or deception are involved, all championship placings will stand.
6. Protests awards in any of the departments of the fair must be made in writing, signed, sworn to and clearly set forth. Protest - Witness- Account forms may be obtained in the Secretary's office on the fairgrounds. The grounds of protest must be filed with the Secretary of the Morrow County Agricultural Society not later than one day after the awards are made.
7. If the protest is made by anyone other than a Senior or Junior Fair board member of the Morrow County Agricultural Society, a \$25.00 protest fee must accompany the protest account which will be retained by the Morrow County Agricultural Society if the protest is not sustained.

### **901-19-33 Prohibited Grooming Practices**

This is a mandatory rule

The following grooming practices are prohibited in junior market livestock shows

- A. Using any substance to enhance or change the color of the livestock, including the livestock's hide or hooves.
- B. Adding any substance externally to build up, change or alter the shape or conformation of the livestock, including by way of example but not limited to rope, false hair, graphite, hemp, and powders.
- C. Pigmented grooming aides or materials; and
- D. Slick clipping or body shaving of market hogs except on the ears and tail.

# OHIO'S LIVESTOCK HEALTH EXHIBITION RULES

## **901:1-18-01 Chapter's application**

(A) Animals listed in this chapter when moved or imported into Ohio for exhibition purposes only shall comply with the requirements of this chapter and when in compliance with the provisions of this chapter shall, with the exception of rules governing movement and importation of quarantined animals, be exempt from any other rules governing movement within or importation into Ohio.

(B) Animals moved within or imported into Ohio for any purpose in addition to exhibition shall meet all movement and import requirements of Chapter 901:1-17 of the Administrative Code.

## **901:1-18-02 Definitions**

As used in this chapter:

(A) "Exhibition" means any public show of animals which is sponsored by or under the control of an Ohio county or independent agricultural society organized under chapter 1711. of the revised code; or the Ohio state fair; or which is assembled for a period which exceeds thirty-six hours or contains animals of origins other than Ohio.

(B) "Certificate of veterinary inspection" means a form from the state of origin which has been issued and completed by a licensed and accredited veterinarian attesting to the health status and identification of an animal listed thereon.

(C) "Approved veterinarian" means any licensed and accredited veterinarian approved by the Ohio department of agriculture, or an employee of the Ohio department of agriculture or the United States department of agriculture, animal plant health inspection service, veterinary services.

(D) "Licensed and accredited veterinarian" means a person who is licensed by the state of Ohio to practice veterinary medicine and who is certified by the United States department of agriculture, animal plant health inspection service, veterinary services, to be an accredited veterinarian.

(E) "Residue" means any poisonous or deleterious pesticide governed by 40 C.F.R. 180, any poisonous or deleterious substance governed by 21 C.F.R. 109.6, or any other substance governed by 21 C.F.R. 556.

(F) "Contagious or infectious disease" means any disease, including any foreign animal disease, or vector, capable of transmission by any means from a carrier animal to a human or to another animal and includes dangerously contagious or infectious diseases.

(G) "Tuberculosis accredited free herd" is one that has passed at least two consecutive annual negative official tests for tuberculosis in accordance with the "Uniform Methods and Rules - Bovine Tuberculosis Eradication", and has no other evidence of bovine tuberculosis.

## **901:1-18-03 Exhibitions: sanitation, inspection and records**

(A) Each entity sponsoring an exhibition shall have in attendance an approved veterinarian for the duration of the exhibit.

(B) Each entity sponsoring an exhibition shall:

(1) Immediately, prior to an exhibition and under the direction of the approved veterinarian, thoroughly clean and disinfect each building, pen, stall, ring or other enclosure in which animals are to be quartered for exhibition;

(2) Have the approved veterinarian:

(a) Examine the certificate of veterinary inspection when required for an animal brought to the exhibition

(b) Inspect within a reasonable time of arrival each animal brought to the exhibit for symptoms of any infectious or contagious diseases;

(c) Daily inspect each animal present at the exhibition for symptoms of infectious or contagious disease.

(3) Maintain a record for one year from the date of the exhibition of each animal present at the exhibit. The record shall contain the name and address of the owner of each animal and the species and breed of the animal.

(4) May order the immediate removal of any animal which in the opinion of the approved veterinarian places other animals at unacceptable risk of disease.

(C) An exemption from the requirements of paragraph (B)(1) of this rule may be requested from the department and will be granted when, in the judgment of the department, cleaning and disinfection will serve no purpose. By way of example only, cleaning and disinfection will generally serve no purpose in a newly constructed building that has never been occupied.

## **901:1-18-04 Exhibitors**

(A) No person shall present for exhibition or exhibit an animal which he knows or has reason to suspect is affected with or has been exposed to a dangerously contagious or infectious disease or residue.

(B) The owner or bailee of an animal with symptoms of an infectious or contagious disease shall, when directed by an exhibition official, the approved veterinarian, or an employee of the Ohio department of agriculture, immediately remove the animal from the exhibition premises.

(C) Upon request, each person who presents for exhibition or exhibits an animal, shall make available any certificate of veterinary inspection, registration certificates, vaccination certificate, and other documents to exhibition officials, the approved veterinarian or an employee of the Ohio department of agriculture.

(D) Each person who presents for exhibition or exhibits an animal for which a certificate of veterinary inspection is required by rules 901:1-18-01 to 901:1-18-11 of the Administrative Code shall forward a copy of the certificate of veterinary inspection to the Ohio department of agriculture's division of animal industry.

## **901:1-18-05 Poultry and fowl**

(A) All turkeys, chickens and game birds moved within or imported into Ohio for exhibition must:

(1) Originate directly from a flock or hatchery which is a participant in the national poultry improvement plan for the eradication of disease and be accompanied by documentary evidence that they meet the requirements of this paragraph; or



- (2) Originate directly from a flock which has had a negative test for pullorum/fowl typhoid disease within twelve months preceding the opening date of exhibition and be accompanied by documentary evidence that they meet the requirement of this paragraph; or
  - (3) Have had a negative test for pullorum/fowl typhoid disease, within ninety days, preceding the opening date of the exhibition and be accompanied by documentary evidence that they meet the requirement of this paragraph; or
  - (4) Be tested for pullorum/fowl typhoid disease upon arrival at the exhibition by a tester approved by the Ohio department of agriculture and found negative.
- (B) The rapid whole blood test shall not be used to test turkeys for compliance with the requirements of paragraph (A)(2),(A)(3) and (A)(4) of this rule.
- (C) Waterfowl, doves and pigeons are exempt from this rule.

**901:1-18-06 Cattle**

- (A) Cattle moved within Ohio for exhibition:
- (1) The animals presented for exhibition must show no symptoms or evidence of an infectious or contagious disease.
- (B) All cattle imported into Ohio for exhibition must:
- (1) Be accompanied by a certificate of veterinary inspection issued within thirty days preceding the opening date of the exhibition and be identified with official individual identification;
  - (2) Originate from a tuberculosis-accredited free herd, an accredited free state or zone, or a modified accredited advanced state or zone;
  - (3) If originate from a modified accredited state or zone must comply with Rule 901:1-17-03 of the Administrative Code;
  - (4) If originate from an accreditation preparatory or a non-accredited state or zone are prohibited from exhibition;
  - (5) If from a brucellosis class A state or area/zone must be negative to an official brucellosis test within thirty days of the opening date of the exhibition unless: they are under six months of age, steers, or official vaccinates under twenty months of age (dairy) or twenty-four months of age (beef); and
  - (6) If from a brucellosis class B or C state or area/zone must meet all requirements for pre-entry testing as specified in 9 C.F.R. 78.9 and obtain an Ohio permit prior to movement.
- (C) Cattle from a brucellosis certified free herd or class free state or area/zone are not required to be brucellosis tested.

**901:1-18-07 Goats**

- (A) Goats moved within Ohio for exhibition:
- (1) The animal presented for exhibition must show no symptoms or evidence of an infectious or contagious disease.
  - (2) All sexually intact animals and any wether eighteen months of age and older must be identified with an official identification as defined in rule 901:1-13-04 of the Ohio Administrative Code.
- (B) Goats imported into Ohio for exhibition:
- (1) Must be accompanied by a certificate of veterinary inspection issued within thirty days preceding the opening date of the exhibition and be identified with official individual identification;
  - (2) The animal presented for exhibition must show no symptoms or evidence of an infectious or contagious disease; and
  - (3) The owner and the veterinarian must attest to the following statement written on the certificate of veterinary inspection "the goats in this shipment are not known to be under any movement restrictions because of scrapie."
  - (4) Originate from a tuberculosis accredited free herd as defined in rule 901-18-02 (G) of the Administrative Code for bovine tuberculosis eradication; or
  - (5) Originate from a bovine accredited free state or zone, or a bovine modified accredited advanced state or zone; or
  - (6) Originate from a bovine modified accredited state or zone must comply with Rule 901:1-17-06 of the Administrative Code.
- (C) If originating from a bovine accreditation preparatory or a bovine non-accredited state or zone are prohibited from exhibition.

**901:1-18-08 Horses, mules and ponies**

- (A) Horses, mules and ponies moved within Ohio for exhibition:
- (1) If not under quarantine and if they are free of any signs of a contagious or infectious disease; and
  - (2) If the animal is twelve months of age or older, the exhibition manager may require that the animal has been tested and classed negative to an official test for equine infectious anemia within twelve months of the opening date of the exhibition.
- (B) Horses, mules and ponies imported into Ohio for exhibition:
- (1) Shall be accompanied by an official certificate of veterinary inspection issued within thirty days of the opening date of the exhibition; and
  - (2) If the animal is twelve months of age or older, it shall be accompanied by evidence the animal was negative to an official test for equine infectious anemia within twelve months of the opening date of the exhibition; and
  - (3) Upon request by an authorized representative of the Ohio department of agriculture, the person responsible for each animal must make available a chronological list of dates, places and events attended by this animal within thirty days prior to entry into Ohio.

**901:1-18-09 Sheep**

- (A) Sheep moved within Ohio for exhibition:
- (1) The animal presented for exhibition must show no symptoms or evidence of an infectious or contagious disease.
  - (2) All sexually intact animals and any wether eighteen months of age and older must be identified with an official identification as defined in rule 901:1-13-04 of the Ohio Administrative Code.

- (B) Sheep imported into Ohio for exhibition:
- (1) Must be accompanied by a certificate of veterinary inspection issued within thirty days preceding the opening date of the exhibition and be identified with official individual identification; and
  - (2) The animal presented for exhibition must show no symptoms or evidence of an infectious or contagious disease; and
  - (3) The owner and the veterinarian must attest to the following statement written on the certificate of veterinary inspection "the sheep in this shipment are not known to be under any movement restrictions because of scrapie."

**901:1-18-10 Swine**

- (A) Swine moved within Ohio for exhibition:
- (1) The animals presented for exhibition must show no symptoms or evidence of an infectious or contagious disease.
  - (2) Will be exempt from the requirement of a certificate of veterinary inspection if they originate immediately and directly from a pseudorabies stage V area.
  - (3) Swine originating from a pseudorabies stage IV area shall:
    - (a) Be accompanied by a certificate of veterinary inspection issued within thirty days preceding the opening date of the exhibition; and
    - (b) Originate from a pseudorabies qualified herd; or
    - (c) Be negative to an official pseudorabies test within thirty days of the exhibition.
- (B) Swine imported into Ohio for exhibition:
- (1) Must be accompanied by a certificate of veterinary inspection issued within thirty days preceding the opening date of the exhibition; and
    - (a) Originate immediately and directly from a pseudorabies stage V area or an area or country recognized by the United States department of agriculture, animal plant health inspection service, veterinary services as pseudorabies free; or
    - (b) Originate immediately and directly from a pseudorabies stage IV area; and
    - (c) Be negative to an official pseudorabies test within thirty days of the exhibition.

**901:1-18-11 Llama**

- (A) Camelids including, but not limited to, llamas, alpacas and vicunas moved within Ohio for exhibition when presented for exhibition must show no symptoms or evidence of an infectious or contagious disease.
- (B) Camelids including, but not limited to, llamas, alpacas and vicunas imported into Ohio for exhibition:
- (1) Must be accompanied by a certificate of veterinary inspection issued within thirty days preceding the opening date of the exhibition and be identified with official individual identification.
  - (2) When presented for exhibition must show no symptoms or evidence of contagious disease.

## OHIO'S LIVESTOCK TAMPERING EXHIBITION RULES

**901-19-01 Definitions.**

As used in Chapter 901-19 of the Administrative Code:

- (A) "Accessory reproductive tissue" includes but is not limited to epididymis.
- (B) "Agricultural society" or "society" means a county agricultural society or an independent agricultural society that is organized under the laws of the state of Ohio.
- (C) "Approved" when used in reference to drugs, means approval by the United States food and drug administration for use in the species indicated on the label.
- (D) "Breed show or class" means a show or class limited to breeding stock of a specific breed of livestock.
- (E) "Class" means a division within a show or exhibition as defined by a sponsor.
- (F) "Department" means the department of agriculture created under section 121.02 of the Revised Code.
- (G) "Designee" when used in reference to an exhibitor, means a member of the exhibitor's family or household or any other registered or authorized representative of the exhibitor.
- (H) "Director" means the Ohio director of agriculture appointed pursuant to section 121.03 of the Revised Code.
- (I) "Drenching" means the act of using an instrument, including a bottle, placed in an animal's mouth to orally administer a liquid, food, or any other substance.
- (J) "Drug" means drug as defined in division (C) of section 4729.02 of the Revised Code and its metabolites.
- (K) "Drug use notification form" means the document completed in accordance with rule 901-19-06 of the Administrative Code.
- (L) "Exhibition drug residue legal" means an animal has not been administered a drug; or if administered a drug the withdrawal period has elapsed at the time the drug use notification form is completed.
- (M) "Exhibitor" means any person who shows, displays, or exhibits livestock at an exhibition.
- (N) "Extra label use" means the actual or intended use of a drug in livestock in a manner other than in accordance with the drug label directions.
- (O) "Fair" means the annual exhibition held by the Ohio expositions commission, pursuant to division (A)(1) of section 991.03 of the Revised Code, or a county agricultural society or independent agricultural society, as reported to the director pursuant to rule 901-5-11 of the Administrative Code.
- (P) "Family" means the immediate family of an exhibitor, including but not limited to the exhibitor's parent, step-parent, foster parent, grandparent, step-grandparent, foster grandparent, brother, sister, step-brother, step-sister, half-brother, half-sister, son, daughter, step-son, step-daughter, or guardian.

- (Q) "Grand champion" means the highest placing livestock entry of a show.
- (R) "Household" means the permanent residence address of the exhibitor.
- (S) "Immediately" means the time period between the cessation of administration of a drug and the point at which drug residues in the livestock are within tolerance levels or at zero tolerance, unless a safe level has been established by the United States food and drug administration.
- (T) "Internal rule" means any rule adopted by a sponsor or applicable to the sponsor's exhibition, and includes all mandatory rules and those optional rules from which the sponsor does not exempt itself or its exhibition.
- (U) "Junior livestock show" means a show limited to exhibitors nine years of age or in the third grade through nineteen years of age, or as authorized to participate in either 4-H, FFA, or other youth organization.
- (V) "Label" means the attached label or the accompanying brochure that lists the approved species, dose, route of administration, withdrawal time and any cautionary statement; a prescription label; the requirements of labeling for an extra label use drug as permitted by the United States food and drug administration; and information provided by the food animal residue avoidance databank (FARAD).
- (W) "Licensed livestock facility" means a livestock facility licensed pursuant to Chapter 943. of the Revised Code or a similar law of another state.
- (X) "Mandatory rule" means any rule adopted by the director relating to food safety or the health, safety, or welfare of livestock and from which a sponsor may not exempt itself or its exhibition.
- (Y) "Market flock style project" means ownership including an individual junior exhibitor, family of a junior exhibitor or a cooperative made up of junior exhibitors. Through this type of ownership, the junior exhibitor(s) are to care for, groom, and select any and all birds to be used in exhibitions as well as actively participate in any decision making processes for the flock.
- (Z) "Market livestock" means exhibition livestock bred, raised and intended for slaughter for food purposes.
- (AA) "Market poultry" means birds including, but not limited to, meat chickens, turkeys, geese and ducks.
- (BB) "Non-terminal show" means a show in which no livestock is required to be slaughtered.
- (CC) "Optional rule" means any rule adopted by the director from which a sponsor may exempt itself or its exhibition.
- (DD) "Outstanding market project" means the exhibitor ranking highest in the outstanding market project competition in a show.
- (EE) "Over the counter drug" means any drug that lawfully may be purchased without a prescription.
- (FF) "Partial terminal show" means a show in which no fewer than the grand champion and reserve grand champion in each show or market class of livestock are sent directly to slaughter or to a licensed livestock facility no later than or immediately following the conclusion of the exhibition.
- (GG) "Prescription" means prescription as defined in division (G) of section 4729.02 of the Revised Code.
- (HH) "Quarantine" means isolation pursuant to section 941.07 of the Revised Code.
- (II) "Reserve grand champion" means the second highest placing livestock entry of a show.
- (JJ) "Residue" means residues as defined in division (I) of section 941.01 of the Revised Code.
- (KK) "Show" means that part of the exhibition restricted to exhibiting a single species and category of livestock such as, by way of example, but not limited to, market steer, dairy goats and market lambs.
- (LL) "Slick clipping" or "body shaving" means having hair that is less than one half inch in length on the body of market hogs.
- (MM) "Terminal show" means a show in which all livestock entered in the show are sent directly to slaughter or to a licensed livestock facility no later than or immediately following the conclusion of the exhibition.
- (NN) "Tolerance level" means the detectable level of a residue or other substance in livestock, in a livestock test sample, or in food, as that word is defined in division (A)(2) of section 3715.01 of the Revised Code, in a level less than or equal to the maximum level determined to be safe, acceptable or non-violative by the United States food and drug administration.
- (OO) "Unlawful substance" means any of the following:
- (1) Any drug prohibited by division (E)(1)(b) of section 901.76 of the Revised Code; or
  - (2) A substance which is not normally found in or does not naturally occur in livestock; or
  - (3) A substance which is normally found in or does naturally occur in livestock, but is detected or discerned in an amount or area greater than normal; or
  - (4) Any drug required to be listed, but which is not listed on a drug use notification form; or
  - (5) Any drug present in an animal regardless of how the drug came to be present if the drug was not administered under paragraph (A), (B) or (C) of rule 901-19-04 of the Administrative Code.
- (PP) "Veterinarian" means any person licensed to practice veterinary medicine under Chapter 4741. of the Revised Code or under the similar laws of another state.
- (QQ) "Withdrawal period" or "withdrawal time" means the interval from the time livestock is removed from medication until all residues are within the tolerance level.

#### **901-19-04 Prohibited practices.**

This is a mandatory rule.

No person shall:

- (A) Administer or cause or permit to be administered a prescription drug to livestock either immediately before an exhibition or during an exhibition unless the prescription drug is administered:
- (1) By or under the supervision and direction of a veterinarian;
  - (2) Only in accordance with label directions;
  - (3) In conjunction with a valid veterinarian-client-patient relationship;
  - (4) For a valid medical purpose; and,
  - (5) A drug use notification form is completed and filed in accordance with the applicable requirements of rule 901-19-06 of the Administrative Code.
- (B) Administer or cause or permit to be administered an over the counter drug to livestock either immediately before an exhibition or during an

exhibition unless the over the counter drug is administered:

- (1) By or under the supervision or direction of the exhibitor, the exhibitor's designee, the owner of the livestock or a veterinarian;
  - (2) Only in accordance with label directions;
  - (3) Only for a valid medical purpose; and,
  - (4) A drug use notification form is completed and filed in accordance with the applicable requirements of rule 901-19-06 of the Administrative Code.
- (C) Administer or cause or permit to be administered either a prescription drug or an over the counter drug other than in accordance with the drug's label directions unless extra label use of the drug is:
- (1) By or under the supervision and direction of a veterinarian;
  - (2) Only in accordance with the extra label directions provided by the veterinarian;
  - (3) In conjunction with a valid veterinarian-client-patient relationship;
  - (4) For a valid medical purpose;
  - (5) A drug use notification form is completed and filed in accordance with the applicable requirements of rule 901-19-06 of the Administrative Code;
- and,
- (6) An extended withdrawal time is assigned to the drug by the veterinarian as part of the extra label directions and reported on the drug use notification form.
- (D) Show, sell, or offer for sale any livestock which contains an unlawful substance or has been subjected to unacceptable practices as outlined in rule 901-19-03 of the Administrative Code.
- (E) Show any livestock which contains a drug in an amount which exceeds the tolerance level if established or safe level; or, a drug for which the withdrawal period has not elapsed unless administered in accordance with paragraph (A), (B) or (C) of this rule.
- (F) Sell or offer for sale in an auction at a terminal or partial terminal show an animal that contains a drug in an amount which exceeds the tolerance level if established or safe level; or, a drug for which the withdrawal period has not elapsed unless administered in accordance with paragraph (A), (B) or (C) of this rule.
- (G) Exhibit an animal which has been tranquilized.
- (H) Make a false statement on a drug use notification form.
- (I) Fail to file or update a drug use notification form as required by 901-19-06 of the Administrative Code.
- (J) Negligently cause an unlawful substance to be present in an animal.
- (K) Fail to sign a chain of custody form.
- (L) Violate a mandatory rule.
- (M) Violate any optional rule from which a sponsor or exhibition did not exempt itself.
- (N) Fail to render assistance as provided by section 901.73 of the Revised Code.

#### **901-19-06 Drug use notification.**

This is a mandatory rule.

- (A) The exhibitor and the owner of an animal are jointly and severally responsible for completing and filing out the drug use notification form in the manner required by this rule.
- (B) The drug use notification form shall be signed by either the exhibitor or the owner. If the person signing the form is a minor child, the form shall be cosigned by a parent or guardian of the minor child.
- (C) A drug use notification form shall be completed for every animal from which a test sample is collected at every terminal and partial terminal or non-terminal show, and for every animal that is administered a drug either immediately before or during an exhibition.
- (D) The director shall require a drug use notification form to be completed for the following livestock exhibited in a junior livestock show:
  - (1) Market steer;
  - (2) Market hog;
  - (3) Market lamb;
  - (4) Veal calf;
  - (5) Market dairy steer;
  - (6) Market goats;
  - (7) Market poultry;
  - (8) Lactating dairy cattle; and
  - (9) Lactating goats.
- (E) The drug use notification form shall be filed with the records official prior to the show in which the animal is entered.
- (F) The director may require a drug use notification form to be completed for livestock exhibited at any type of show including a non-terminal show.
- (G) If the information on the form regarding drug use changes or if a drug is subsequently administered at any time after the drug use notification form is filed, an updated drug use notification form shall immediately be filed with the records official.
- (H) No person shall submit an incomplete, illegible or unsigned drug use notification form.
- (I) When a drug use notification form submitted to a records official for livestock is incomplete, illegible, or unsigned neither the exhibitor nor the owner shall, until the defect is corrected:
  - (1) Receive any prizes or awards from shows in which the livestock was exhibited prior to the time the drug use notification form was to be filed.
  - (2) Participate in any shows or sales held subsequent to the time the drug use notification form was to be filed.

**901-19-07 Quality assurance.**

This is a mandatory rule.

(A) Except as stated in paragraph (B) of this rule, sponsors shall require exhibitors at fairs sponsored by county or independent agricultural societies or the Ohio exposition commission to annually attend or complete a quality assurance program sponsored and conducted cooperatively by the exhibition sponsor, Ohio state university extension, Ohio agricultural education, or agricultural commodity organizations.

(B) At the discretion of Ohio state university extension, or Ohio agricultural education, an exhibitor may pass a test based on the appropriate skill level for their age (twelve to fourteen or fifteen to eighteen) under the supervision of Ohio state university extension or Ohio agricultural education before exhibiting terminal or partial terminal market livestock, including market poultry, lactating dairy cattle and lactating goats in a junior livestock show. Youth who pass the test will be exempt from annual quality assurance re-certification until they move to the next age bracket or they are no longer a junior exhibitor (nineteen years of age or older on January first of their last year). Minimum standards for youth food animal quality assurance are as set forth in appendix A to this rule.

(C) Exhibitors who fail to attend or complete a quality assurance program or fail to pass the exam as outlined in paragraph (B) of this rule may be subject to the disciplinary actions listed in rule 901-19-21 of the Administrative Code.

**901-19-09 Drug residues in non-terminal show animals.**

This is a mandatory rule.

(A) A person may, notwithstanding paragraph (E) of rule 901-19-04 of the Administrative Code, show at a non-terminal show an animal which has been administered a drug provided they are in compliance with all of the following:

(1) The drug is a prescription drug or an extra label use of a drug and the drug is prescribed by a veterinarian pursuant to a valid veterinarian-client-patient relationship;

(2) The drug is administered or used only in accordance with label directions or the prescription;

(3) The drug is administered or used only for medical purposes; and,

(4) A drug use notification form is completed and filed in accordance with the applicable requirements of rule 901-19-06 of the Administrative Code.

(B) Milk or other food obtained from livestock which has been administered or treated with a drug and permitted to exhibit pursuant to paragraph (A) of this rule, shall not be used for human consumption.

**901-19-10 Testing requirements and test results.**

This is a mandatory rule.

(A) Urine, blood, tissue and other test samples shall be collected in accordance with the department's protocol for the collection of livestock test samples at exhibitions. Test samples may be collected before, during, or immediately after a show. Deviation from the protocol shall be noted.

(B) The director may at his discretion, collect any urine, blood, tissue, or other test samples from exhibition animals at the time of slaughter.

**901-19-11 Humane treatment of livestock.**

This is a mandatory rule.

(A) A person shall treat livestock in a humane manner and in accordance with acceptable commercial practices so as to protect the health, safety, and welfare of the livestock.

(B) All exhibitors shall comply with and abide by the policy statement and "code of practices" of the Ohio livestock coalition.

**901-19-12 Acceptable practices.**

This is a mandatory rule.

The following practices are deemed acceptable to protect and promote the health, safety, and welfare of livestock:

(A) Adding caffeine free soda pop, gelatin, or other sweeteners to drinking water in nominal amounts to encourage water consumption;

(B) Hoof trimming;

(C) Cosmetic dehorning in market class livestock;

(D) Using collodion as a teat sealant, but for no longer than eighteen hours;

(E) Adding molasses or other sweeteners to feed to encourage consumption;

(F) Properly administered and approved growth implants;

(G) Castration;

(H) Beak trimming;

(I) Dehorning;

(J) Tattooing;

(K) Hot or freeze branding;

(L) Humane ringing;

(M) Tail docking;

(N) Ear notching;

(O) Ear tagging;

(P) Shearing;

(Q) Drenching of livestock for a medical condition at an exhibition when diagnosed by a licensed veterinarian;

(R) Acceptable surgery, including clamps, bands and chemical castration; and

(S) Application of ice, ice packs, cold packs, or cold compresses prescribed to relieve heat stress or a medical condition diagnosed by a licensed veterinarian at an exhibition.

**901-19-13 Unacceptable practices.**

This is a mandatory rule.

The following practices are detrimental to the health, safety, and welfare of livestock and are prohibited:

- (A) Applying any electrical, mechanical, or other appliance to livestock repeatedly or for a prolonged time period in violation of 9 C.F.R. 313.2 (1979);
- (B) Hitting, striking, beating, or otherwise impacting livestock that induces swelling or enhances, transforms or changes the true conformation, configuration, or appearance of the livestock;
- (C) Applying any electrical, mechanical, or other appliance that enhances, transforms, or changes the true conformation, configuration, or appearance of the livestock, unless prescribed by the exhibition veterinarian;
- (D) Plugging of teats;
- (E) Sealing of teats using unapproved substances or for longer than eighteen hours using approved substances;
- (F) Injecting material into udders or teats for non-medical purposes or otherwise artificially modifying the appearance or conformation of the udder or teat;
- (G) Using ice, ice packs, cold packs, or cold compresses internally or externally other than in accordance with paragraph (S) of rule 901-19-12 of the Administrative Code;
- (H) Using a stomach tube or pump for any purpose other than for the relief of tympany or gas on the day of exhibiting;
- (I) Drenching of livestock at an exhibition is prohibited except as permitted under paragraph (Q) of rule 901-19-12 of the Administrative Code.

**901-19-19 Absolute liability.**

This is a mandatory rule.

- (A) Both the exhibitor and the owner of livestock are absolutely liable to discipline under rule 901-19-21 of the Administrative Code for the presence of an unlawful substance in livestock and unacceptable practices done to livestock.
- (B) If the exhibitor or the owner was a minor child at the time the unlawful substance or unacceptable practice was detected, the parent or guardian of the person shall also be absolutely liable to discipline under rule 901-19-21 of the administrative Code for the presence of an unlawful substance in livestock and unacceptable practices done to livestock.
- (C) The director or the sponsor when imposing discipline under paragraph (A) of this rule upon a person, may mitigate the discipline imposed based upon one or more of the following facts if established.
  - (1) The person did not introduce the unlawful substance into the animal or do any unacceptable practices to the livestock;
  - (2) The person had no actual or constructive knowledge that the unlawful substance was introduced into the livestock or that unacceptable practices had been done to the livestock;
  - (3) The unlawful substance was not introduced into the livestock and the unacceptable practices were not done to the livestock through the person's negligence.

**901-19-21 Disciplinary action.**

This is a mandatory rule.

- (A) Any person who violates a provision of sections 901.70 to 901.76 of the Revised Code or any provision of this chapter is subject to any of the following disciplinary actions:
  - (1) Disqualification from any exhibition;
  - (2) Disqualification of the exhibition livestock from any exhibition;
  - (3) Continuing education;
  - (4) Written letter of reprimand;
  - (5) Forfeiture or return of awards, prizes, premiums, or proceeds; or
  - (6) Pre-exhibition drug testing.
- (B) Disqualification may include any or all shows and classes and may be for any number of years.
- (C) Anyone who violates rule 901-19-07 of the Administrative Code may be given a letter of reprimand for the first offense.

**901-19-33 Prohibited grooming practices.**

This is a mandatory rule.

The following grooming practices are prohibited in junior market livestock shows unless those grooming practices are permitted under rule 901-19-32 of the Administrative Code:

- (A) Using any substance to enhance or change the color of the livestock, including the livestock's hide or hooves;
- (B) Adding any substance externally to build up, change or alter the shape or conformation of the livestock, including by way of example but not limited to rope, false hair, graphite, hemp, and powders;
- (C) Pigmented grooming aides or materials; and
- (D) Slick clipping or body shaving of market hogs except on the ears and tails.

**901-19-38 False, deceptive or unacceptable practices.**

This is a mandatory rule.

The following are unacceptable practices:

- (A) Castration of livestock for purposes of this rule which exceed the following criteria:
  - (1) Cattle over eight months of age;
  - (2) Swine over seventy-five pounds; or

- (3) Sheep over seventy-five pounds.
- (B) Showing any market livestock which has been treated in accordance with paragraph (A), (B) or (C) of rule 901-19-04 of the Administrative Code when a side effect of the drug conceals, enhances, transforms, or changes the true conformation or condition of the livestock.
- (C) Any natural occurrence or surgical process which results in testicular tissue remaining in the body of exhibition livestock except rabbits and poultry.

**901-19-39 Ownership requirements.**

- (A) No exhibitor shall register, enter, or exhibit in a junior livestock exhibition any of the livestock listed in paragraphs (A)(1) to (A)(7) of this rule unless the household, as defined in paragraph (R) of rule 901-19-01, at which the exhibitor is registered at has owned the livestock for not less than the length of time listed:
  - (1) Market steers - one hundred fifty days;
  - (2) Market dairy steers - one hundred fifty days;
  - (3) Market hogs - sixty days;
  - (4) Market lambs - sixty days;
  - (5) Market goats - sixty days;
  - (6) Veal calves - sixty days; and
  - (7) Market poultry - within five days of hatch including all individual participants in a cooperative.
- (B) No exhibitor shall register, enter, or exhibit livestock in a junior breeding livestock exhibition unless the household, as defined in paragraph (R) of rule 901-19-01, at which the exhibitor is registered at has owned the livestock or has had the livestock registered under the exhibitor's name for at least sixty days.
- (C) For any exhibition other than those listed in paragraphs (A)(1) to (A)(7) and paragraph (B) of this rule, the length of time a person shall own livestock before the person may register, enter, or exhibit the livestock at an exhibition may be set by either the sponsor of the exhibition or a breed association.

# SHOWMANSHIP

As an animal exhibitor, showmanship is your chance to shine as an individual. Showmanship classes give you the opportunity to exhibit the knowledge you have acquired and the showing techniques you have learned. We want to encourage all our exhibitors to participate in a showmanship class for each of the species they bring to the fair. **Showmanship is not required to receive a premium for a completed project. HOWEVER, YOU MUST SHOW IN SHOWMANSHIP IN ORDER TO BE ELIGIBLE FOR CHAMPION PROJECT.** Showmanship must be an animal entered and exhibited in the Jr fair by the same exhibitor. The animal cannot be checked in under another exhibitor.

Showmanship classes will be divided and judged according to the following age categories (except horses): (Age as of January 1, current year) **Senior** – 16 to 18; **Intermediate** – 13 to 15; **Junior** – 11 to 12; **Beginner** – 8 to 10 (Age 8 and in the third grade) Showmanship classes begin with the Senior class and move down to the Beginner class giving the younger exhibitors the chance to watch and learn from the more experienced. Showmanship winners must advance to the next higher category regardless of age.

**Exception**-Horse exhibitors see Horse and Pony Guide.

## Recommended Attire for Showmanship

Exhibitors attire for showmanship classes, as well as the judging classes should show respect for yourself and the events you are entering. Below are recommendations for the different species:

**Market Goats:** Dark pants, white collared shirt, sturdy shoes.

**Dairy Goat:** White Pants, White collared shirt, sturdy shoes.

**Pygmy Goat:** Khaki pants, white collared shirt, sturdy shoes.

**Dairy Cattle:** White pants, white collared shirt (may have farm logo), sturdy shoes.

**Beef Cattle:** Dark pants, collared shirt, sturdy shoes.

**Horse:** Long sleeve Western or English attire, western hat should have a minimum of a 2” brim, boots.

**Swine:** Dark jeans, collared shirt, sturdy shoes.

**Rabbit:** Long sleeve white shirt or jacket, slacks or jeans.

**Poultry:** Long sleeve white shirt or jacket, slacks or jeans.

**Llama & Alpaca:** Dark pants or jeans, collared shirt (long or short sleeved), sturdy shoes.

Except for the horse division, you should not wear a hat. Stay away from shirts with print, sandals and shorts. Also, make sure you have all the appropriate equipment for your species and know how to use it while in the class. No royalty or Jr. Fair Board identifiers should be worn while showing. Be sure to sign up for the appropriate class and good luck!

**Master Showman** from each species will be selected from the current year Beginner, Junior, Intermediate and Senior Class Champions and Past Senior Showmanship winners who are still exhibiting as Junior Fair exhibitors. The Master Showman contest will be held at the end of the regular species showmanship event except for horses (see horse department schedule), all goats will have theirs on Saturday during the Market Goat Show and feeder calves will have theirs at the end of the Dairy Feeder Showmanship. There must be a minimum of two (2) participants to warrant the contest. **YOU MAY WIN MASTER SHOWMAN MORE THAN ONCE. You may win Master Showman and compete again in Master Showman *even* if you have won Showman of Showmen.**

**Participants in showmanship contests must show an animal which they have entered and exhibited in the Junior Fair.**

## SHOWMAN OF SHOWMEN CONTEST

Sunday, of the Fair 2 pm. Starting in the Horse Arena

The past & present winners of any Senior Showmanship are eligible for this contest if they are still a current exhibitor. Once a member has won Showman of Showmen, they will NO LONGER be able to compete in Showman of Showmen. These same exhibitors will have the opportunity to participate in a Master Showman contest in any species in which they have already won the Senior Showmanship category until they are no longer eligible for Junior Fair. Each contestant will be showing an animal from each of these species: beef, dairy, goat, horse, rabbit, poultry, swine, and sheep. (Order for current year will be posted by the sign up poster along with any other pertinent information.) **Contestants will be responsible for supplying their own equipment but not get their own animals.** Animals will be provided. Members should not handle one of their own animals in the contest. The Tie Breaker for this competition will be an oral question given by the county 4-H or Ag Educator, or the Junior Fair Coordinator. **MANDATORY SIGN UP on Poster in Large Show Arena - BEFORE 10:00 pm Saturday night of the Fair!**



**THE 2024 MORROW COUNTY JUNIOR FAIR**  
**Livestock Sale Rules**

Morrow County Junior Fair exhibitors who are eligible may sell their market animal Monday, September 2, 2024 at the designated time and place. **Dairy feeders, hogs, goats, lambs, market beef, and beef feeders will be sold In the Show Arena beginning at 10 a.m. Pen of 3 rabbits, market rabbits, chickens, geese, turkeys, and ducks will be sold In the Small Arena beginning at 10:30 a.m.**

**The Following Rules Will Apply to This Sale**

1. Only market animals that have been duly entered, judged and graded in regular Junior Fair competition will be eligible for sale. All sale entries must have met the requirements of the Junior Fair.
2. The Directors of the Sale Committee shall make the final decision regarding the salability of any sale entry, including but not limited to health and body condition.
3. Any animal not passing meat inspection is the responsibility of the seller.
4. Responsibility included but is not limited to all costs associated with the project.
5. No non-livestock items may be sold through the Livestock Sale except for the benefit of the Morrow County Junior Fair Building Fund. Non-Livestock items must be approved by the Directors prior to the sale.
6. **Digital Sale cards for each species must be submitted within 15 minutes after the end of its market show.** Exhibitors submitting a late sale card **before 10pm Saturday** will be charged a \$50 penalty. Late sale cards submitted **after 10pm Saturday** will sell their project at the end of the species with a \$75 penalty. **Exhibitors not presenting their project to sell in the assigned order** will sell their project at the end of the species with a \$150 penalty.
7. **Exhibitors submitting multiple sale cards will sell the project on the last sale card submitted per the time stamp of submission.**
8. All animals will be weighed at times posted at the Junior Fair Office during the fair. Disputes must be settled while the animal is on the scale. Re-weigh immediately requires the animal to exit the scale, scale zeroed, and animal reenters the scale for final weight. Final weight must be used.
9. The following commission will be charged for animal sold:
  - Grand Champion 3% of sale value
  - Reserve Grand Champion 2% of sale value
  - Others 1% of sale value
10. Each exhibitor is responsible for his or her animal up to the earlier of: the animal being picked up by the buyer, 6 pm sale day or when barn/sale area is restricted for load out.
11. No animal will be resold.
12. All animals will be sold by the head or project.
13. Grand and Reserve Champion Market Beef, Lambs, Goats, and Hogs must be slaughtered at the processing facility designated by the Senior Fair Board. Buyers of the animals are responsible for both the base and premium bids.
14. **Market Steers, Market Hogs, Market Goats, Market Lambs, and Poultry sold through the sale are terminal and must go to the base bidder or processor of choice.**
15. **Rabbits sold through the sale are to go directly onto the truck of the base bidder. They are not to go home with the exhibitor.**
16. No sale animals may be removed from a processor's truck/trailer.
17. The sale of an underweight animal as an extra to a base bidder will be at the Junior Fair Sale Committees discretion.
18. All sale checks will be voided after 90 days of issue. Checks may be re-issued with a \$56.00 reissue fee.
19. The Junior Fair Sale Committee reserves the right to restrict and/or limit any person's access to the barns and/or loading area, in, near and/or around equipment and/or other areas used in conjunction with the livestock sale on sale day. Any person(s) found to be in violation of this rule may be subject but not limited to warning, removal and/or debarment from the fair and/or loss of other privileges associated with the Morrow County Fair. Violators may face legal action. Violators will be subject to the majority vote of the Junior Fair Livestock Sale Committee directors.
20. All questions or disputes regarding the sale of livestock, including but not limited to the interpretation or application of these rules, shall be determined by the majority vote of the Directors of the Sale Committee. The determination of the Sale Committee shall be subject to final review and approval by the majority vote of the Senior Fair Board and the decision of the Senior Fair Board shall be final and binding.

# **CODE OF CONDUCT**

## **FOR THE MORROW COUNTY AGRICULTURAL SOCIETY**

**The Morrow County Agricultural Society (MCAS) is an agricultural expositions and youth-service, community-based organization dedicated to providing a show place for youth and adults. Participation in the organization's programs is subject to the observance of the organization's rules and procedures. The activities outlined below are strictly prohibited while representing the MCAS, while on the job or performing any duties. Any participant or staff member who violates the Code, is subject to discipline up to and including discharge.**

- Use of foul, vulgar, inappropriate language or gestures towards a board member, staff member, employee, volunteer, or another participant.
- Possession or use of alcoholic beverages on MCAS property or reporting to the program while under the influence of drugs or alcohol.
- Possession or use of illegal drugs on MCAS property or reporting to the program while under the influence of drugs.
- Bringing onto MCAS property dangerous or unauthorized materials such as explosives, firearms, weapons, or other similar items, unless permitted by Federal or State law.
- Discourtesy or rudeness to a board member, staff member, employee, volunteer, or other participant.
- Verbally, physically, visually, or sexually harass another board member, staff member, employee, volunteer, or another participant.
- Actual or threatened violence toward any individual or group.
- Conduct endangering the life, safety, health, or well-being of others.
- Failure to follow any agency policy or procedure.
- Taking unfair advantage of any participant thru bribery, blackmail, bullying, intimidation, or belittling.
- Inappropriate dress (ie: short shorts, low cut tops, short skirts, tops with vulgar graphics or wording).
- Destruction of property (i.e. graffiti, etc....).
- Posting, listings, pictures that are deemed inappropriate regarding the fair/ fairgrounds on social media forums.
- Steal or be in possession of stolen property.
- Commit a felonious act.
- Abuse towards any animal or livestock

### **Consequences of Misbehavior:**

- Notification to appropriate member, volunteer, participant, employee/staff. The adult, youth and/or volunteer involved in the violation will be notified or made aware of the violation by the MCAS Executive Committee or the MCAS Board of Directors.
- Restricted and/or prohibited from participation in future events.
- Paying for financial cost of damages and repairs for damages or the destruction of property.
- Released to the nearest law enforcement agency and or the proper authority.
- Removal from the MCAS Board of Directors or club organization.
- Premiums or prize monies may be forfeited upon MCAS Board ruling.

Complaints to be brought before a Review Committee. Both sides of the complaint to be heard/reviewed by the committee and any necessary action will be determined by a majority vote of the committee. Committee to be made up of MCAS President, MCAS Vice President, 2 MCAS Board Directors, and 1 member appointed by MCAS President.

NOTE: Department head and 1 Jr. Fair Advisor/Member may be asked to participate if the situation deems their involvement.

**Exhibitors must comply with the above MCAS Code of Conduct and will agree to terms before submission of entries.**

  - b. Sportsmanship and conduct at the Fair
  - c. Citizenship
  - d. Students must be in or entering an accredited, post-high school academic program.
  - e. Individuals may only receive the scholarship once.
2. Scholarships will be paid at the presentation ceremony. Monies are given to help with college expenses.

Presented Tuesday evening, 6:30 pm, before the Queen/King Contest in the Youth Building. Citizenship Awards are presented each year to two Outstanding Morrow County Junior Fair Exhibitors (preferably one boy and one girl). These awards are presented in recognition of the citizenship these youth have shown. Applicants must be a current Jr. Fair exhibitor, and at least 16 years old.

## JUNIOR FAIR KING AND QUEEN

Participants must be a current Junior Fair Exhibitor, and 16 years old or at least a Junior in high school. They cannot be over 19 as of January 1st. Participants must first submit an application **and** an advisor recommendation to the Junior Fair Coordinator. Applications and recommendations are available through the Junior Fair Office, County Extension Office and on the County Extension Office website. **Deadline date will be June 7th. Applications are to be uploaded into FairEntry.** All applicants must go through a judge's interview. The **interviews will take place on July 14th at the Junior Fair Office.** A specific time will be scheduled once applications are received. The Judges interview is worth 50% of your total score. The interview judges are responsible for selecting and placing five candidates each for King and Queen. Placing is worth the following points: 1st - 50, 2nd- 45, 3rd - 40, 4th - 35, 5th - 30. Candidates will be notified by mail or phone call of the choice of the interview judges. The names and a short resume of the final five candidates for both King and Queen will be placed in the Sentinel and displayed in the Jr. Fair youth building. All Junior Fair Exhibitors will have the opportunity to cast one vote each for King and Queen. The voting will take place during Skillathon in August as well as the move-in Monday of the fair. These votes will be counted, and will be worth 45% percent of the total score. A fish bowl question during the King and Queen Presentation will be worth 5% and totaled with the interview judge's score and voting. In case of a tie, the winner will be determined by the voting of the exhibitors.

#### GENERAL RULES

1. Steers and Market Heifers must have been owned and cared for by the Exhibitor since December 1, 2023.
2. **Steers and Market Heifers will be weighed First Monday of the fair, between 4pm and 7:30 pm Animals Will be weighed once. This will be the official weight throughout the Fair. Any discrepancy or questions of weight by the owner shall be decided and settled while the animal is on the scales.**
3. Steers and Market Heifers must weigh 800 pounds and up.
4. An exhibitor may show 3 market animals in this division.
5. Underweight steers & market heifers will be shown, graded in special classes & are not allowed to compete for Grand Champion or sell.
6. Registered steers must show registration papers on move-in day. The breed is declared at the December weigh-in.
7. There are to be no fresh tattoos on registered animals. Tattoos must be legible on weigh in day.
8. If an animal does not have registration papers it will be placed in the crossbred class.
9. Market Beef are to be claimed as BBR at the time of the December weigh-in. The "County raised" box must be checked in FairEntry animal information screen to be entered in BBR by the June 7th deadline.
10. The BBR classes are divided by weight NOT by breed. BBR Grand & Reserve Grand will be sent to the final drive and scratched from their regular market classes.
  - a. The Cattlemen's Association will provide the awards for the BBR classes.
  - b. The BBR Champions will follow the Grand and Reserve Champion Market Beef in the sale lineup.
11. The Morrow County Cattlemen's Association (MCCA) will sponsor a Bred and Owned Heifer Class for Jr. Fair participants.
  - a. Heifer must qualify under rules and classification of a junior fair project.
  - b. Heifer must have legal registration from the breed association. Crossbreds do not qualify.
  - c. Exhibitor **must be** the breeder and owner of his/her heifer. Breed registration papers need to be presented on move-in Monday. Farm names will not be accepted and must have the individual's name only. Tattoos must be legible and match papers.
  - d. MCCA reserves the right to break classes if necessary.
  - e. Bred & Owned Heifers will show at the conclusion of the breeding show.
12. The top 3 in a breed will be brought back to show in champion cattle drive.
13. Fans are to hang from the side, one fan per animal, and not to interfere with any other project. No butt fans.
14. There are to be no gates or panels between animals in the same family or farm except to separate large steers from smaller feeders or calves with board approval.
15. Steers and beef breeding projects will be dismissed from the fair only after the last steer has sold in the livestock sale. Stalls must be cleaned by the exhibitor and checked by a fair board member before the exhibitor may take final leave of the grounds.
16. Steers and Market Heifers can be shown with grooming products that are approved for use on meat animals. **State fair rule:** any product which changes, enhances, or alters the natural color of the animal will not be permitted. Included, but not limited to; paints, dye, powders, non-clear adhesives, and foams or shoe polish. This will also apply to Morrow County.
17. Soap and water only are to be used on the steers and market heifers for sale day.
18. No bedding shall be laid until after 1:00 pm on the Sunday before fair. Pen assignments will not be hung until after 1:00 pm. Do not move pens without permission from a fair board member. RECOMMENDED BEDDING for Barn and Tie Outs; Straw, sawdust, SMALL CHIPS. If you use large/shredded bark or chips it is the exhibitor's responsibility to remove it by the end of the fair, (midnight of the last day, unless cleared through a SR. Board member), bark is a hazard to those spreading the manure.
19. TENTS: No sign up required for Tents, one 10x10 per family can be set up after 1pm on Sunday, set up day before the fair. Tents or place markers stationed prior may/will be removed by the Jr Fair Board.
20. We will use the State Fair breed qualifications. You can pick up a copy in the Junior Fair office if you need to see it.
21. Feeder Calves are to be born from January 1 thru April 1, 2024.
22. Feeder calves may be male or female. Beef and Dairy Calves must be weaned, dehorned, castrated (males), cutting or banding is recommended, MUST be healed. If not, the animal will be dismissed from the fair.

23. Feeder Calves are to weigh from 350 to 799 pounds.
24. Underweight and overweight feeder calves will be shown in special classes and not allowed to compete for Grand Champion and cannot sell. They also may not compete in BBR classes.
25. An Exhibitor may show up to 3 market animals in this department; any combination of the two divisions.
26. There are to be no gates or panels between animals in the same family or farm except to separate large steers from smaller feeders or calves with board approval.
27. Feeder calves are required to have shipping fever shots (respiratory vaccinations) in order to show at the fair. The first one is given at the June weigh in. The second one should be given 30 days later, but no later than August 1<sup>st</sup>. The cost is \$10.00 per calf if purchased from the Jr. Fair Board. Keep shots refrigerated until needed.
28. Feeder calves will be dismissed from the fair only after the last feeder has sold in the livestock sale.
29. The Dairy Feeder Show will be divided into light weight, medium weight, and heavy weight classes. Awards for champions in each of these classes will be sponsored by the Morrow County Dairy Association. The Grand Champion and Reserve Grand Champion Dairy Feeder will be chosen from these weight class champions.
30. Dairy & Dual will use this rule: Dairy Classes will consist of the 6 major breeds in America, Ayrshire, Brown Swiss, Guernsey, Holstein, Jersey, Milking Shorthorn or a combination of them. If the animal is a dairy breed not listed, crossed with one of the American breeds or crossed with a beef breed it will show as a Dual Feeder.

**Harness and Pack goat classes do not need a breed clarification.**

Classes:

- **Pack Goat** – any age, any ability (1st yr. goat should be able to carry an empty pack and should be able to navigate with the exhibitor like they are on a trail. This is NOT a glorified obstacle course. 2<sup>nd</sup> yr. goat should navigate with exhibitor and be able to carry a light load in their pack. 3<sup>rd</sup> yr. goat should be able to navigate with the exhibitor and be able to carry a heavy pack.) If you have questions, please call the Jr Fair office.
- **Harness Goat (1st year project)** - goats must be halter broken and led on a lead strap. Animal should respond to voice commands of stop, go, back, left, and right.
- **Harness Goat (2nd year project)** - goats will be harnessed and pull an empty cart. The animal should respond to voice commands of stop, go, back, left, and right.
- **Harness Goat (3 or more years)** - goats will be harnessed and pull a child-driven cart. The animal must respond to commands of stop, go, back, left, and right while pulling the cart through an obstacle course.

### GENERAL RULES

**All goats, claiming to be a specific breed must have a copy of breed registration papers. If you have no registration papers they will show as utility animals. Registration papers will be due move-in day of the fair. Animals must be checked in before unloading in the barn!!**

1. Market Goats will weigh in on 1<sup>st</sup> Monday of the fair, 4-5:30 pm in the small arena. If you are unable to make this time, you may weigh your goat(s) during the market lamb weigh in but no later than 7:30 pm. Minimum weight is 50 lbs. The goats will be weighed once. This will be the official weight. Weight discrepancy is settled on the scales. If there is a discrepancy on the scales, the animal will be taken off the scales, scales will be zeroed out, animal will be put back on and reweighed. 2<sup>nd</sup> weight will be the recorded weight.  
All underweight market goats (Under 50 lbs) will be shown and graded in a special class and are not allowed to compete for champion, compete in BBR nor will they sell.
2. Dairy, breeding and market goats must be shorn before show day. (It is recommended that the goats be shorn prior to the fair.)
3. Lactating dairy goats are to be in place by 8 am on Thursday and will be released at 3 pm or following the show, whichever is later, that same day.
4. Exhibitors are always to keep water in front of their goats.
5. An Exhibitor may show only two market goats.
6. All goat exhibitors will be responsible for making the allotted pen retain their goat(s) with material they provide themselves. They are not to use gates and panels needed to make additional pens for exhibitors.
7. Dairy goats are to be shown with choker chains. Pygmy goats are to be shown with collars and a short lead. Prong collars will be allowed in the show arena.
8. Registered and unregistered Boer breeding goats, Angora goats and Pygmy goats can have horns.

15. Be prepared to have someone at your pen at 9:30 am, Tuesday of the Fair, for the State Vet scrapie check and have any registration paperwork available. Tattoos must be legible.
16. Bracing or not bracing of goats is a personal preference and is up to the exhibitor.
17. Registered animals that are microchipped must also be tattooed according to the USDA rules. Animals that are not properly tattooed will not be admitted. If you have questions, please call the Jr. Fair office.
18. BBR and market shows are two separate shows. Champion and Reserve Champion BBR will be eligible to show in the market classes and compete for Grand and Reserve Grand market goat. Being Champion or Reserve Champion BBR will not automatically give you a spot in the final drive of the market show.

6. Trainers are to have no contact with the exhibitor or animal on the fairgrounds during the duration of the fair.
7. Helmets are mandatory while riding or driving an equine.
8. **Stalls must be cleaned by the exhibitor and checked by a Horse and Pony advisor or Junior Fair Board member, before taking final leave of the grounds.**
9. The Horse and Pony Department animals will be dismissed from the Fair at 3 pm on Labor Day.
10. Any Horse registered as a Junior Fair project may be used by a parent or sibling, with permission, only during open shows at the Morrow County Fair.
11. There should always be water kept in front of the animal.
12. Stalls must be cleaned by 10am. Exhibitors will be given a verbal warning for the 1st offense, written warning for the 2nd, and will go before Jr Fair Board on 3rd offense and could be asked to leave for the remainder of the fair.
13. All feed / grain must be stored in a LOCKED tack box if in the barn. All hay and straw must be stored in your trailer.
14. **No Smoking** within 50 feet of the barn.
15. Riding allowed in the arena and working arena only. (No Riding in the Barn or on either side of the barn.) All horses and ponies must remain at a walk outside of the arena or work area and must be led outside of the arena and area.
16. No parking of vehicles inside of the fenced off area.
17. It is Mandatory to keep horses and ponies inside the fence, away from all food wagons or stands.
18. Scheduled practice sessions in the arena will be allowed from daybreak until ½ hr. before show and from conclusion of show each day until 11:00 pm
  - English practice will be Wednesday
  - Contest Practice - Even Hours
  - Pleasure Practice - Odd Hours.
19. **Horses and ponies are to be ridden by 4-H Horse and Pony project members only.** Failing to abide by this rule may result in dismissal from the fair. (Exception-rule #10)
20. **Clover bud members shall not participate** in any form (riding, sitting or handling) of a 4-H Horse & Pony member's project at any time during the Morrow County Fair.

6- Waterfowl Pair- Breeding Geese and Duck project (male and female same bird type/breed UNDER 1 year by show day.)

7- All Other Birds Pair-Pheasants, quail, pigeons, turkeys (male and female same bird type/breed UNDER 1 year by show day.)

8- Fancy Poultry Pair-Chickens Standard/Large Breed (male and female same bird type/breed UNDER 1 year by show day.)

9- Fancy Poultry Pair-Chickens Small/Bantam Breed (male and female same bird type/breed UNDER 1 year by show day.)

## GENERAL RULES

**Classes 1, 2, 3, 4, ONLY are eligible for Livestock Sale. You may bring up to 5 broilers to the fair to weigh in to get your pen of two with remaining birds being returned home that evening.**

1. All birds are required to have a hatchery paper or bill of sale to prove ownership and hatch dates. Exhibitors will need to be able to provide this at fair check-in.
2. All turkeys, chickens and game birds moved within or imported into Ohio for exhibition must:
  - Originate directly from a flock or hatchery which is a participant in the National Poultry Improvement Plan for the Eradication of Disease and be accompanied by documentary evidence that they meet the requirement of this paragraph; or - Originate directly from a flock which has had a negative test for pullorum/fowl typhoid disease within twelve months preceding the opening date of exhibition and be accompanied by documentary evidence that they meet the requirement of this paragraph; or -Have had a negative test for pullorum/fowl typhoid disease, within ninety days preceding the opening date of the exhibition and be accompanied by documentary evidence that they meet the requirements of this paragraph.
  - Waterfowl, doves and pigeons are exempt from this rule.
  - A copy of the documentary evidence is to be shown & turned in at the Barn check in at the fairgrounds on 1st Monday of Fair.
3. **ALL MARKET PROJECTS ARE TO BE BANDED AT WEIGH IN.**
4. Each domesticated bird exhibited shall be inspected by the Fair Veterinarian.
5. Breeding poultry should be under 1 year of age.
6. If a poultry project is found to be older than the allowed age, it may be judged, but is not eligible for champion or to sell.
7. Underweight Broilers will be shown and graded in a special class and will not eligible to compete for Grand Champion or to sell

8. Overweight Broilers will be shown and graded in a special class and will not eligible to compete for Grand Champion, but will be eligible to sell through the livestock sale.
9. Wood shavings bedding only, no cedar.
10. All poultry projects will be dismissed from the fair after the last market poultry animal has sold in the livestock sale.
11. Jr/Sr. Fair Boards have the right to cut locks on cages in dire situations
12. ALL poultry must be removed from the Poultry Barn on Labor Day/Last Day by 6:00 pm DO NOT remove animals if they DO NOT belong to you.
13. No Supplies, feed, bedding, etc, can be left in the barn during fair week.
14. All top 5 Market Poultry will now sell at the beginning of their respective groups.
15. Pen checks will take place at 10am, 2pm and 6pm

## GENERAL RULES

1. Breeding and Market Rabbits must be checked in and/or weighed in on the 1<sup>st</sup> Monday of the Fair, from 10:00 am-7:30 pm in the Rabbit Barn. **Market rabbits will be weighed once, and this will be the official weight of the fair. Any discrepancy or question by the owner shall be decided while the animal is on the scales.**
  2. The exhibitor/parent must be present during the weigh in/check in of their animals on Monday.
  3. Underweight and overweight rabbits/pen of threes will be shown and graded in special classes and not allowed to compete for Grand Champion/ Reserve. Underweight rabbits will be ineligible to sell at the livestock sale, overweight rabbits will be able to sell.
  4. An Exhibitor may enter 2 single fryers and 2 breeding; 1 pen of three and 2 breeding; 1 single fryer and 3 breeding; or 4 breeding. \*\* The Pen of Three Market Rabbits shall consist of three rabbits, all the same breed and variety. Broken meat pens must also be of the same variety. It is not necessary that they be from the same litter. The age and weight are the same as for a single market rabbit - no more than 12 weeks of age and each rabbit are to weigh from 3.5 to 5.5pounds.
  5. The 'pen of three' will be housed together in one large double cage.
  6. There will be Champion and Reserve Champion single market rabbit and Champion and Reserve Champion 'pen of three' market rabbits and will sell as such. 3rd - 5th placers in each category will sell after the Grand and Reserve Champions.
  7. Breeding Rabbits will be shown in groups according to breed; Market in groups by weight.
  8. There must be at least three rabbits and two breeders to be deemed a breed champion. All classes with less will be combined into one class. This class will be called "All Other Breeds".
  9. Mixed Breed breeding rabbits are not eligible for Best or Reserve Best of Show.
  10. **DO NOT USE CEDAR CHIPS** as bedding.
  11. Jr/Sr Fair Boards have the right to cut locks on cages in dire situations.
  12. **Pens, stalls, and cages must be cleaned by the exhibitor and checked by a Fair board member before the exhibitor may take final leave of the grounds.**
  13. **All rabbit projects, breeding and market will be dismissed from the fair after the last market rabbit has sold in the livestock sale. ALL RABBITS MUST BE REMOVED FROM BARN ON LAST DAY/LABOR DAY BY 6:00 pm DO NOT remove animals that DO NOT belong to you.**
  14. No Supplies, feed, bedding, etc, can be left in the barn during fair week.

- Entries, ID Pictures, and BBR Papers are due JUNE 7<sup>th</sup> of current year loaded into FairEntry.
- The “County raised” box must be checked in FairEntry animal information screen to be entered in BBR by the June 7th deadline.
- No Pre-Fair Weigh In - Photos of each sheep must be submitted including the front, back, and side of the lamb, and scrapie tag.
- Exhibitors may submit information for up to 5 market lambs by June 7th. Only 2 animals entered in FairEntry may cross the scales at fair and be shown. (maximum of 2 market sheep may come to the fair per exhibitor)
- Market Lamb Weigh In: 1<sup>st</sup> Monday of the Fair, 5:30 pm - 7:30 pm in the small arena
- All animal ID’s submitted to FairEntry by one exhibitor at the pre-fair date must be entered and shown by the same exhibitor.
- A maximum of 2 breeding animals per class per breed may come to the fair. (ex/ 2 Oxford ewe lambs, 2 Dorset ewe lambs, 2 Oxford yearling ewes, etc.)
- Market Lambs must weigh 90 lbs by fair weigh in.
- **Scrapie identification is required for ALL sheep. Sheep without USDA compliant scrapie identification will NOT be checked in.**

- Flock ID tattoo (Flock ID is issued by the USDA)
- Registration certificate and tattoo that matches certificate
- Registration certificate and microchip that matches certificate & tattoo telling chip location (T for tail, ET for ear)

## GENERAL RULES

1. Market lamb weigh in will be at the Fair on the first Monday, from 5:30-7:30 pm at the scales located in the Small Arena. This is the official weight of the Fair. Any discrepancy or question of the weight by the owner shall be decided while the animal is still on the scales.
2. All market lambs are to be slick sheared (¼" or less) at fair weigh in, unless the breed declares otherwise, Example: Hair breeds.
3. Lambs will weigh 90 pounds and up.
4. Market lambs must be under 1 year of age and show lamb teeth at Fair weigh in.
5. Underweight Market Lambs will be shown and graded in special classes and not allowed to compete for Grand Champion or sell. They also may not compete in BBR classes.
6. An exhibitor may show **only two market** animals in this division and 2 animals per class for breeding animals.
7. Market lambs will be shown in classes based on breeds.
8. Lambs entered in Breeding Classes may not be shown as Market Lambs.
9. In Market Classes there must be three per breed to be deemed champion. All classes with less will be combined into one class – All Other Breeds. The All Other Breeds Class may consist of less than 3 animals because breed papers have been registered with the Junior Fair office. If an animal does not have breed papers, it will be placed in the crossbred class.
10. The Breeding Show will run by breed while alternating breeds in this order: Yearling Ram, Ram Lamb, Champion Ram, Yearling Ewe, Ewe Lamb, Champion Ewe.
11. Wool Breeds must have at least 1 inch of wool growth upon arrival the 1st monday of fair.
12. In the breeding show Breed Champions (no crossbred breeding lambs) will show for Supreme Overall
13. All sheep must be fit within 10 feet of the barn area.
14. Over the Pen storage will be allowed but it is not to exceed the width of the pen. Storage units in the aisle must not interfere with the day to day business in the barn.
15. All Sheep projects (Breeding and Market) will be dismissed from the fair after the last market lamb has sold in the livestock sale.
16. **All sheep (Junior and Senior Fair)** are to have Scrapie tags, including wethers. When you are buying an animal, it should have a Scrapie tag already in it before you take it home. If you need information on how to get Scrapie tags for your animals, contact, the Jr. Fair Office (947-1567). Or the Extension office (947-1070) Scrapie numbers are to be submitted in FairEntry.
17. There is to be **no carpet** in the sheep pens. Bedding should be straw, sawdust, or mulch only.
18. Sheep may be tied in their pens only prior to showing on a show day (Wednesday, Thursday) or in preparation for Youth Lead on Tuesday.
19. Castration must be healed by the fair.
20. BBR Grand & Reserve Grand will be sent to the final drive & scratched from their regular market classes.
21. The BBR Champions will follow the Grand and Reserve Champion Market Lambs in the Sale lineup
22. No more than one tack pen per family, items and supplies must be specie specific, all feed must be secured for animal safety, storage units in aisles must not interfere with day-to-day business and number of tack pens will be finalized on monday even based on the number of animals brought to the fairgrounds. Tack pens will follow general rule #14 on cleanliness.

Entry in the events listed below is to be done at Skill a thon or at fair on sign up posters in the sheep barn and is open to any exhibitor of sheep at the CURRENT YEAR'S Junior Fair Sheep Show.

All ages are as of January 1st Beginner Youth Lead (ages 8-11) Intermediate Youth Lead (ages 12-14) Senior Youth Lead (ages 15-18)

**SCORING:** 20 points – **Sheep/** is to be clean, alert, walks and stands well. No decoration on the lambs.

25 points – **Lead Ability**/control and lead of animal

25 points – **Poise**/ posture, awareness of animal, smile

30 points – **Attire**/ the outfit must be made of a minimum of 60% wool. Outfits may be dresses, jumpers, or suits and at least 2 pieces. The top of the suit may be a jacket, sweater, blouse, vest or cape. The bottom may be skirt or pants. The wool content of the accessories will not be included in the overall content of the outfit.

1. Previous Youth Lead Division winners must move up to the next level or if they have won the Senior level, are not eligible to compete.
2. Sheep used must be an exhibit of the contestant.
3. Winner of Beginner Youth Lead will be the Morrow County Sheep Junior Prince or Princess.
4. Winner of Intermediate Youth Lead will be the Morrow County Sheep Prince or Princess.
5. Winner of Senior Youth Lead will be the Morrow County Sheep King or Queen.
6. A **Youth Fun Lead** for those ages 8 and under who are not Junior Fair exhibitors will also be held that evening. In this division, there will be two categories, wool and costume. The sheep needs to be one that is already entered in the fair and borrowed for this event. A sign up for this event will be available at the fair in the Sheep barn.
7. As a winner of any of the Youth Lead classes, you will be expected to attend the sheep shows, pass out awards and ribbons, participate in the parade and be present at other events involving sheep.

## BBR - Born Bred and Raised in Morrow County

The Morrow County Pork Producers are sponsoring Bred, Born, and Raised in Morrow County (BBR) market and breeding classes. BBR Market Hog classes will be made up from the hogs **that have been checked as county raised** in FairEntry by June 7th. Swine BBR market classes will be limited to two entries per exhibitor and the decision as to which animals will be placed in the BBR class will need to be made at the fair weigh in.

-The show will run by breed and split into weights if necessary.

-The BBR hogs will all come back to show on Saturday, including the Champion and Reserve.

-The BBR champions will follow the Grand and Reserve Champions in the sale lineup.

-The **BBR & Breeding will show at the same time.**

-The Pork Producers are furnishing all awards for the BBR Gilt classes

-The BBR Champions and the Breed Champions will show for Grand and Reserve Champion Overall.

## GENERAL RULES

1. Fair weigh in will be the first Monday of fair, between 2:30-7:30 pm at the scales designated for Hogs. **Market Swine will be weighed once to determine the official weight for the fair. Any discrepancy of weight shall be decided and settled while the animal is on the scales.** If there are no breed registration papers shown the hog will be placed in the crossbred class. The hog must have a legible tattoo, tag, or ear notch that matches what is on the registration form.

2. All market swine must have a measurable ½” of body hair on the entire body except for the tail and ears which may be of shorter length.

Hair length will be checked on the scales at weigh in and as the animal is in the chute before entering the show arena.

3. Market Swine must weigh 220 pounds and up.
4. Underweight Market Swine will be shown and graded in special classes and not allowed to compete for Grand Champion or sell, nor can they show in BBR classes.
5. There must be three per breed to be deemed champion. All classes with less will be combined into one class called All Other Breeds. The All Other Breeds Class may consist of less than 3 animals because breed papers have been registered with the Junior Fair office. If an animal does not have breed registration papers, it will be placed in the crossbred class.
6. Gilts shown in breeding classes are not to be shown as market hogs. There is to be no cross over from Junior to Senior Fair. Breeding is breeding and market is market.
7. Hogs are to show clean and with water only applied to the animal. No powders, paint, oil or adhesives.
8. Over the pen storage will be allowed but it is not to exceed the width of the pen. Storage units in the aisle must not interfere with the day-to-day business in the barn.
9. Swine projects will be dismissed from the fair after the last market hog has sold in the livestock sale. This includes both breeding and market. **No cleaning or moving out is to be done in the hog barn during the hog portion of the livestock sale.** This is to allow us to run a smooth sale without the complications of having too many people and activities in the barn at the same time.
10. During the Saturday Hog Show, all show/tack boxes and other equipment that are in the aisles of the hog barn will need to be removed by 2 pm and will not come back until after the show is complete.
11. **Extra people are discouraged from being in the barn on show day. 1 EXTRA PERSON PER EXHIBITOR.**
12. 2:3 Rule is used to help set classes for a show, a class must have 2 exhibitors and 3 animals. For BBR classes it will be by breed. For breeding swine, it will be by breed and age
13. Hoses are NOT permitted to be used in the Hog Barn for automatic waters.
14. **Breeding Swine** will be released between 9-11 pm on Sunday of the fair. If breeding swine does not go home at this time, they must wait until the rest of the barn is released on Sale Day.
15. The Market Hog show is a partial terminal show

Trophies will be given to the top 3 racers in each division and the top racer of the day.

Patches will be available to ALL racers.

Old Timers will receive trophies for the top 3 racers ONLY.

7. **Must Register for races on Jr. Fair Entries by June 7<sup>th</sup>.** Each pack participating in the race will be responsible for one or more of the jobs in running the race. Assignments will be made after entries are returned and/or you can volunteer on your entry form.

6. Dish will be judged in the following ways: taste, appearance, complexity, teamwork if done by a team or patrol, cooking technique.
7. Enter as an individual or team of (2). All entrants must be SCOUTS BSA registered in Morrow County.
8. There will be a 1st, 2nd, and 3rd place in each area and a BEST OVERALL. A participant patch will be given to all who participate.
9. A Tasting Party will follow the judging.

## GIRL SCOUTS

### GENERAL RULES

1. The Girl Scouts consider participation in the Morrow County Fair a privilege and an opportunity to share their accomplishments, interests, and ideals. All exhibits and displays must show high quality in effort, originality, neatness, and follow the criteria of the Girl Scout Program.
2. Every registered Girl Scout, Kindergarten through 12th Grade and every registered Girl Scout Troop in Morrow County is eligible to enter. Girls must enter the level she is participating in as of January 1, of the current year.
3. Judging will begin promptly at 9 am with the judging of all troop project entries. Individual project judging will follow immediately. Individual and Troop projects must be judged & exhibited to receive premium.
4. Each exhibitor may enter up to 10 projects, excluding troop projects.
5. Each troop may enter up to 2 projects. The troop leader must make the fair entries and list all the girl's names involved in creating the project. At least three girls must be present at judging from list. Only girls present at judging and exhibit will receive a premium.
6. All projects need to be registered by June 7th and brought to judging on July 15th.
7. Judging is based on the knowledge and experience gained by the girl or troop as stated in the Girl Scout handbook. Originality, creativity, workmanship, construction, and neatness are considered during the judging interview. Girls will be judged on project knowledge, presentation, requirements, attitude, and personal appearance.

8. Troop leader is responsible for contacting the Junior Fair Office (419-947-1567) by 1<sup>st</sup> Tuesday in August to request booth spot for their troop. Booth decoration and projects must be completed by 8 pm the first Monday of Fair.
9. ONLY projects can be exhibited. No to exceed 22x28x22 inches. Exception is clothing projects. Projects must be identified with a project card from the Junior Fair Office that will be available at booth set up. Junior/Senior Fair Board are not responsible for theft.
10. All art material must be matted or framed and ready to hang. Wires, cords, etc., must be securely attached. Valuable craft items should be boxed or under glass.
11. SPECIAL INSTRUCTIONS FOR COOKING ENTRIES: **For all cooking projects, exhibitors must make three different items** (example-bake three kinds of cookies such as peanut butter, oatmeal raisin, and sugar). Bring a sample of one kind and the recipes for all three (ingredients and directions) to judging. Pictures and/or a poster of other two items may also be brought to judging. In the case of pie, cake, and bread the whole entry should be brought to prevent drying out before judging. For cookies, candy or cupcakes, six pieces should be submitted. Refrigeration is not available. Recipe card and/or pictures of project need to be exhibited at the fair. Tasting of food by judge is optional.
12. The Girl Scouts will abide by the rules of the Morrow County Junior Fair. Entries will not be judged which do not follow all the rules in the current year Junior Fair Book. When an exhibit is deemed not worthy by the judge, no premium or ribbons will be awarded.
13. Fair pass rules apply.
